ABOUT THE Sheriff



Sheriff Ron Hain



Sheriff Ron Hain, is the chief principal law enforcement officer of the County, he is the only full-time elected County law enforcement official provided for by the Illinois Constitution.

Sheriff Hain is responsible for numerous and diverse services. In addition to providing direct law enforcement and public safety service to all citizens in unincorporated Kane County, the Sheriff's Office also supplements and assists other law enforcement agencies in the County as needed. The Sheriff's Office works closely with and provides assistance to the social service agencies in the County. Along with general law enforcement, criminal investigations, and public safety services, the Sheriff also provides other services including, but not limited to, Multi-Jurisdictional SWAT, School Resource Officers for Kaneland and Central School Districts, Too Good For Drugs instructor, bomb detection canine units, narcotic detection and criminal apprehension canine units, Office of Emergency Management, and Bomb and Hazardous Materials Response Unit. The Sheriff also maintains dockets, registers, jail records, fingerprints, and arrest files. Writs and warrants are executed, and summons and subpoenas are served. The Sheriff's deputies also attend all courts on record, and accept and receipt bail in accordance with the rules of the Circuit Court.

Sheriff Hain maintains the Kane County Jail, which is located within the Public Safety Building and has a total capacity of 640 detainees. These individuals are serving court sentences or awaiting trial in lieu of bail.

Kane County Sheriff's Court Security Officers provide security of the 7 courthouses within Kane County. These officers have arrest power solely connected to their function in the courthouse.

Message from Sheriff Ron Hain

Dear Kane County Community,

2021 did not offer a lull in the unprecedented times we have experienced over the last three years. The Kane County Sheriff's Office continued to operate in an agile and dynamic capacity in support of other divisions of the county and our municipal partners during the continuing pandemic. Deputies have been assigned alongside Health Department workers and local nurses to give shots and monitor health immediately afterward at the Kane County Mass Vaccination Clinic.

Meanwhile, we continued to focus on our robust diversion programming in the Kane County Adult Corrections Center. Later in this report, you will find information on the many different opportunities we offer to detainees to improve themselves and re-enter the community with employment, continued addiction counseling (if needed), and never return to the justice system. The three years of data that we have collected clearly show that this new approach of being supportive of justice-involved people is the toughest on crime a sheriff can be.

This work has reduced the opioid overdose of the formerly incarcerated by 89%; reduced recidivism from a six-year average of 49% down to 18% in 2021; the jail population was reduced by 24%; and in parallel, countywide crime is down 16%. These results, along with the Sheriff's Electronic Monitoring Program, has saved Kane County tax payers an estimated \$4,911,000 over the last three years.

2021 also saw a violent year toward law enforcement officers, nationwide, with a 55% increase in the number of officers killed in the line duty. In 2019, we implemented the Sheriff's Tactical Training Unit whose focus would be to operate monthly stress-induced, self-defense, and de-escalation firearms and hand-to hand combat training for all 250-plus badge and gun carriers at the Sheriff's Office. I also immediately began working with our outstanding County Board to fund and implement the best equipment, vehicles, and firearms for our deputies. Looking back over the past few decades, we can confidently say that the Sheriff's Office is now the best trained, equipped, funded, and prepared than ever before.

We are proud to be a strong part of designing a new justice system that reduces crime, supports marginalized citizens, and protects our sworn personnel, countywide. As I enter the last year of my first term as your Sheriff, it has been an honor to serve and keep you safer from the start.

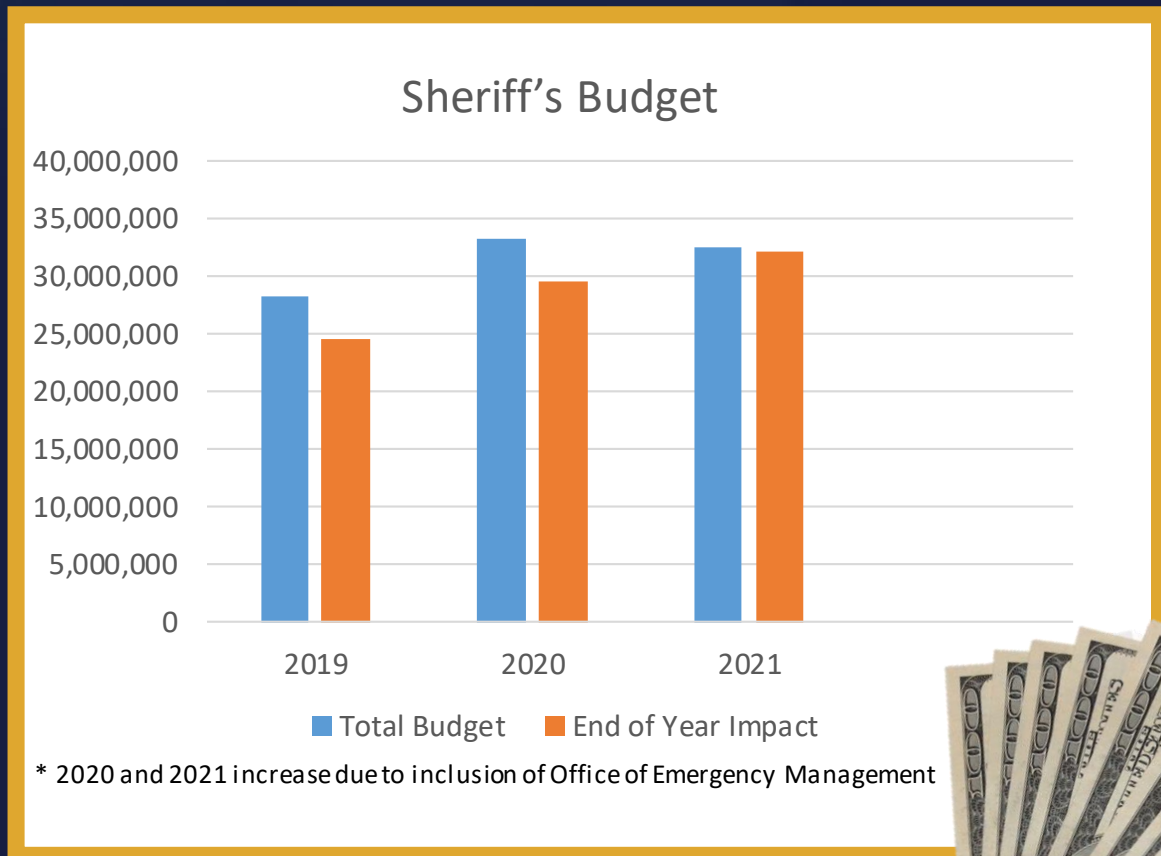

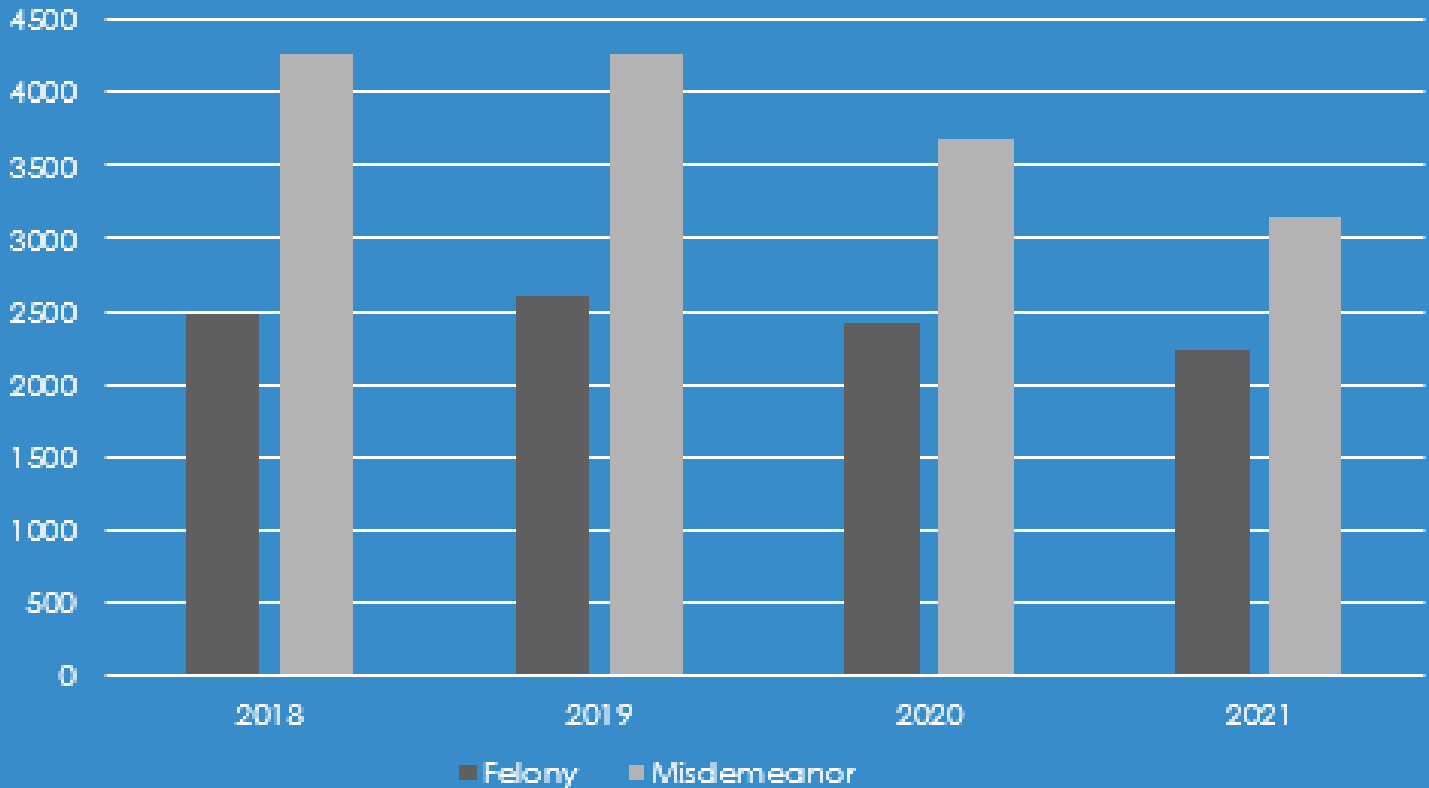

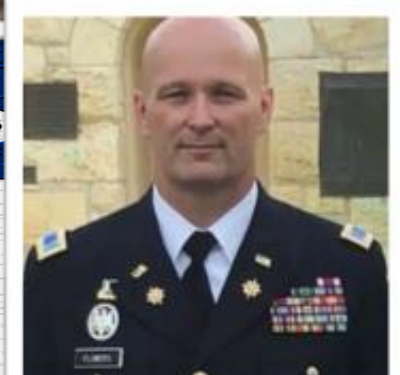

BIOGRAPHY

Ron has served in law enforcement for over 22 years and has been credited with hundreds of major criminal arrests. Ron has worked in varying capacities, to include; narcotics officer, canine handler, SWAT Team leader, and developed, implemented, and supervised the Sheriff's Office Criminal Interdiction Team. Ron is a nationally recognized expert in interstate criminal and terrorist interdiction. Ron Hain has received five meritorious service awards and two Deputy of the Year awards for several successful major criminal investigations. He was also twice nominated for the Kane County Officer of the Year Award. Ron also received the nationally-presented "Relentless Award" in 2013 for his work in criminal interdiction. In his career, Ron Hain has seized over 4,000 lbs. of dangerous drugs and over \$3,000,000 in illicit currency, along with hundreds of illegally possessed firearms associated with those crimes.

Ron was elected as Kane County Sheriff in November of 2018 and his team immediately implemented employment diversion programs into the jail, along with medically assisted treatment to support and redirect inmates with drug addiction issues. Sheriff Hain's focus is to take a zero tolerance approach to street crime while providing positive life paths for incarcerated Kane County residents in an effort to drive down recidivism and crime rates.

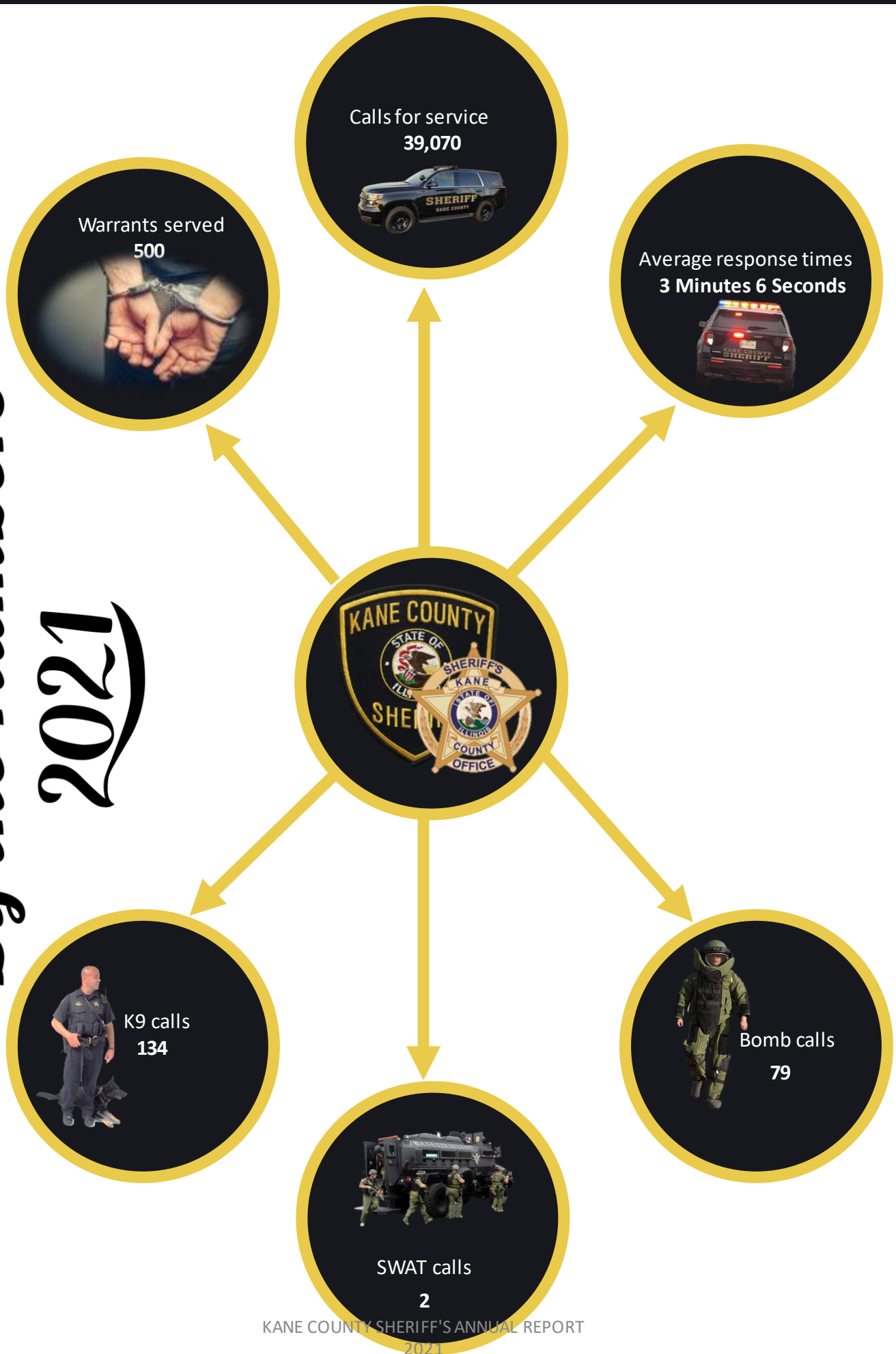
BIOGRAPHY

Commander Chris Peeler is the Commander of Public Safety for the Kane Sheriff's Office. Commander Peeler joined the Kane County Sheriff's Office in 1993 after serving in the US Army. He was promoted to Sergeant in 2002 and Commander Public Safety in mid-2019. During his career, he has worked in the Sheriff's Office Patrol Division, Narcotics Unit, and Investigations Division, both as a Deputy and Supervisor.

Commander Peeler spent 22 years as an operational member of the Special Weapons and Tactics Team and was a Team Leader on one of the assault teams. He also spent 12 years as an operational member of a state-wide counterterrorist team (ILEAS Region North WMD SRT) and was a Team Leader on one of their assault teams.

Sheriff's deputies are committed to the safety of all Kane County citizens. They patrol a diverse land area of 522 square miles on a daily basis that is comprised of thirty municipalities. Deputies respond to calls located in the county's urban corridor nestled along the Fox

River, as well as the rural agricultural area along the western portion of the county. They take pride in protecting the county's 515,269 citizens (2010 Census Bureau).

The public safety team is inspired to make Kane County a great place to live, work, and raise your family.

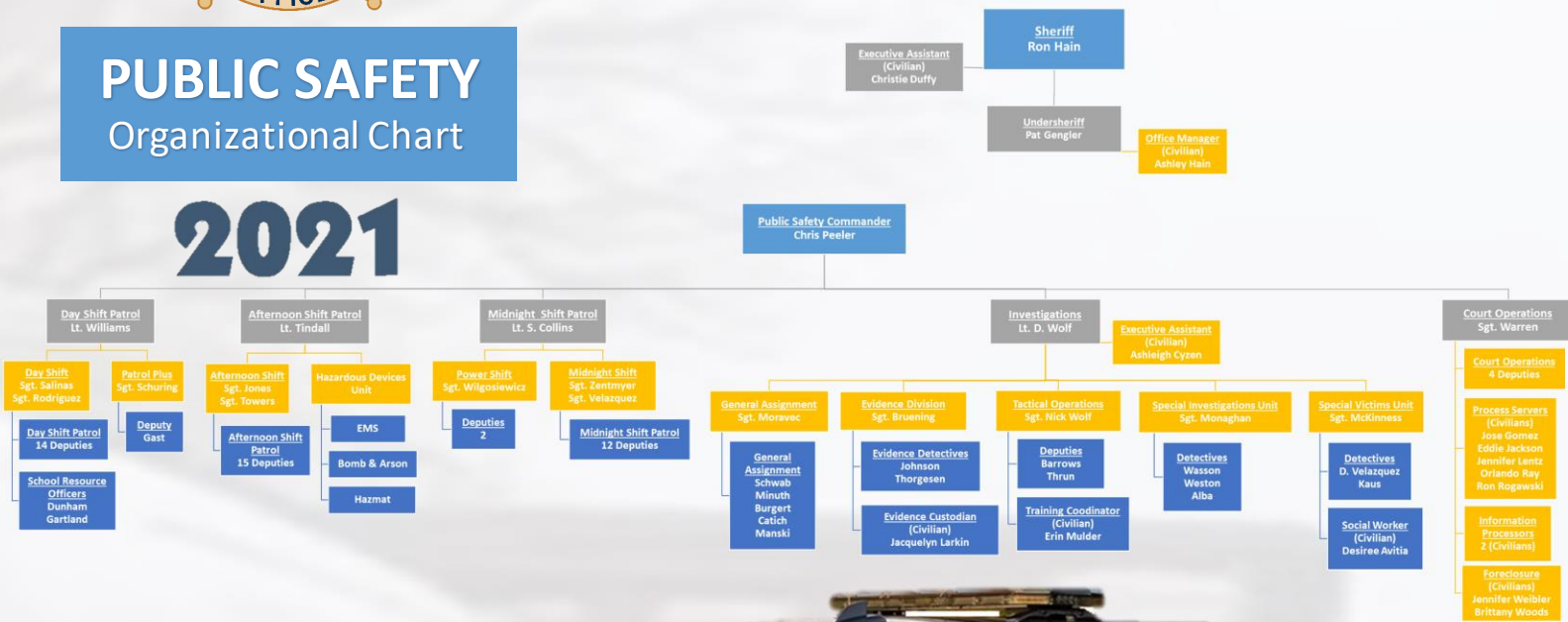

SIU SPECIAL INVESTIGATIONS UNIT

KCSO KANE COUNTY SHERIFF'S OFFICE



The Kane County Sheriff's Special Investigations Unit uses a collaborative approach to reduce the impact of illicit drugs within Kane County. This unified effort includes Sheriff's deputies assigned to highway interdiction to counter the negative consequences of drug trafficking organizations using highways to distribute contraband.

The Kane County Special Investigations Unit assigns deputies to a Homeland Security Investigations Task Force. These deputies supplement HSI's investigative mission to combat narcotics smuggling, money laundering, human smuggling and trafficking, counterfeiting and fraud.

Also, one deputy was assigned to the United States Marshals Service. The purpose of regional fugitive task forces is to combine the efforts of federal, state, and local law enforcement agencies to locate and apprehend the most dangerous fugitives and assist in high profile investigations.

This concept allows the Kane County Sheriff's Special Investigations Unit is to maximize available resources and reduce the duplication of efforts.

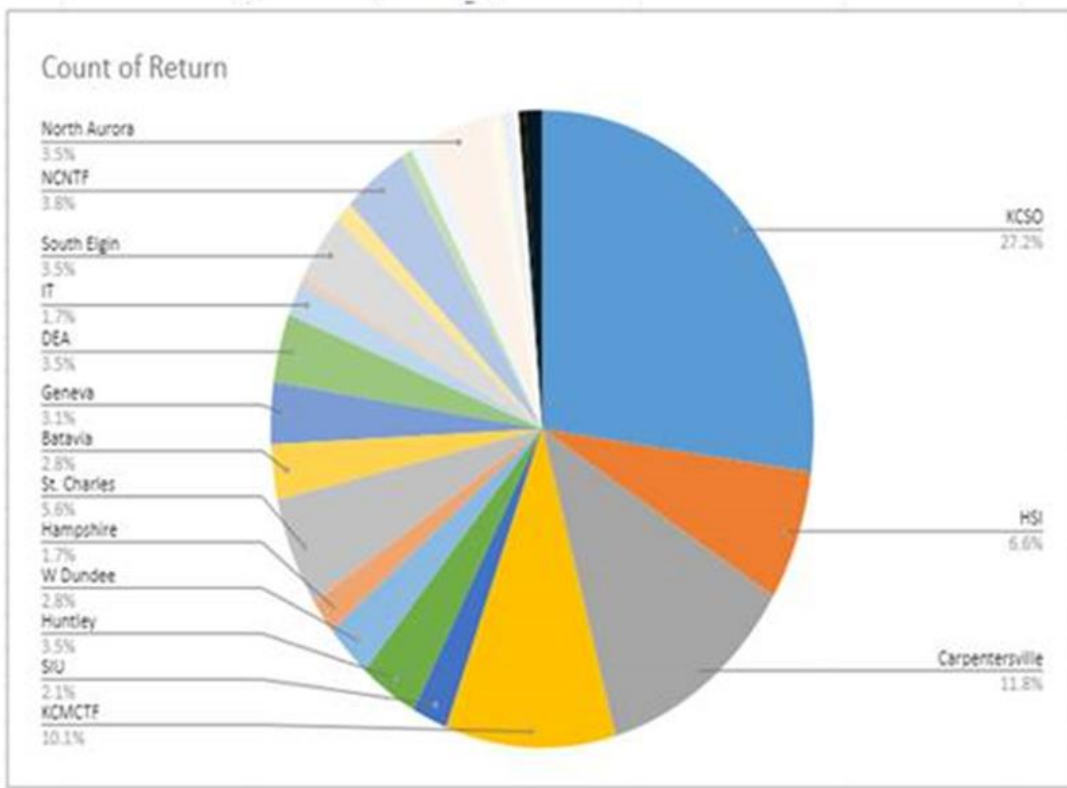

This letter is written in commendation and appreciation for the Kane County Sheriff's Officers who have aided our family over the past month. Our sixteen year old son has been struggling for some time with mental health and substance abuse issues. We first asked for assistance due to my son leaving the house without permission in early January. Deputy Perkins arrived to our home and immediately started coordinating with the North Aurora Police Department. Between Deputy Perkins and the North Aurora Police Department they located my son. Deputy Perkins brought him home and sat with our family for 30 minutes. He showed caring concern for my son and our whole family. His communication to my son was firm, but kind and it was clear he was not just "doing his job", but truly cared about the trajectory of our family. He later called my wife to check on us and offered any future assistance he could provide.

Unfortunately, several days later, our son expressed feelings of wanting to harm himself while he was under the influence. He again left the house without permission and I called for assistance. Deputy Kenneth Johnson arrived and immediately went to work coordinating with the North Aurora Police Department and other local departments to locate my son. Our moments of panic were met with calm, yet a sense of urgency. Our son was located without incident in Yorkville and transported to the hospital where his needs were met. Deputy Johnson's expeditious handling of the situation may have saved my son from grave danger.

While [REDACTED] was receiving inpatient care, on Friday January 22nd, I summoned a small group of friends who have law enforcement backgrounds to my home to search for any illicit items before my son came home. Officer Matt Goncher was a personal connection from a friend and helped facilitate a call to Sergeant Steven Jones. Within minutes, I received a concerned call from Sergeant Jones asking how he could help. I expressed my interest in the potential of a K9 Unit to aid in our search and he immediately scheduled a Kane County K9 unit for the first available opening (1/24). He then did several things that shocked me. First, he asked if we needed a couple of deputies to aid in the search and sent them out within two hours. Deputy Steven Burch and Deputy Garcia arrived and immediately jumped in to help. Without any condemnation or judgement, they empathetically demonstrated concern for me and my wife. These deputies didn't just help, but went into locations I hadn't even thought of and these actions gave us increased peace of mind.

If this was all that happened it would have been truly humbling, but Sergeant Jones then went as far as coordinating an Aurora Police Department K9 Unit/Officer Aaron Spooner to our home that very night. Again, in a time that felt humiliating for me and my wife, Deputy Spooner professionally and compassionately treated us with respect and empathy. This additional effort aided our search efforts and comfort.

While we were still searching, Sergeant Jones himself arrived. He talked with us and aided the others in the search effort. After we finished searching, Sergeant Jones, Deputy Burch, and Deputy Garcia stayed and talked briefly. They reassured me and my wife that we were doing the right things. We have questioned our parenting despite logic, however these men who see the ugly of society daily, provided reassurance and a compassionate perspective that was so appreciated.

Sheriff Hain, you should be very proud of the men and women working in your department. If the men we dealt with are a reflection of your entire department you certainly have one of the best in the state. At a time when much of society vilifies law enforcement, your department is a paradigm for all that is right with policing.

WE CARE

Dear Officers, Sgt. S. Rodriguez, Officer D. Kopf and Kane county sheriff's office,

On July 30th 2019 I had a bad relapse on alcohol, I had been struggling with alcoholism for a long time. I received my 2nd DUI on July 13th 2019, I lost my job, health Insurance, home, and license. I stopped drinking on my own for 17 days. I knew I needed help but couldn't afford it and I called all these rehabs that would accept me if I would be able to pay 9,000 dollars up front. After losing my job and having no insurance I felt like there was no way out. I started drinking again while residing at my sister's house. I woke up the next day on July 31st 2019 and my sister not knowing what to do with me called the Kane County Sheriff's office. I'll never forget that day when there was a knock on the door and I could see multiple police cars outside, I thought I was in trouble or something. I decided to open the door anyways, outside was 3 officers Sgt. S. Rodriguez, Officer D. Kopf and I can't recall the other gentleman's name. For the first time in my life a police officer asked who I was and after I told them they said "we are here to help you" "I'll never forget the feeling. I explained that I knew I needed help and I just didn't have the money to get the right help. They replied with that's fine we have what's called "a way out" program. Most places for alcoholics or addicts are 28 days long for someone with a drinking problem as bad as I had that wouldn't do much. Kane county sheriff's office found me a treatment center called Haymarket Center in downtown Chicago, drove me there and I got a 90 day treatment. That gave me enough time to get sober and straightened out. I would like to thank you for giving me my life back. I've been sober since July 31st when they took me to Haymarket and I will have 2 years sober and counting. I now speak at rehabs to show others struggling with alcohol and any type of addiction that there is a way out if you work for it. I'm now a United States Marine, in good standing. With an award that was given to 1 marine from each Platoon. I've had a few times in jail and probation, but my story can be of use today for others struggling that change can be made and it required a lot of waivers to get in the marine corps but with sobriety you can do anything including transforming from inmate to Marine. Plus I'm free from my addiction to alcohol. Thanks to God, my family and friends , Kane County Sheriff's Office, A Way Out Program, and my own hard work. I hope this reaches both officers and helps others.

Commander Pete Osmani was appointed Commander of the Corrections Facility in 2021. The Kane County Sheriff's Office Corrections Division is the largest of all four components of the Office. Consisting of 124 sworn staff members and 12 civilian support members, the Kane County Adult Corrections Center serves Kane's 532,000+ population. The facility contains 640 beds across 10 cellblocks, also known as "pods." To provide a full cache of services, the Corrections Division details staff over various roles, to include; pod officers, transportation officers, intake and release officers, shift sergeants, intake and release sergeants, shift lieutenants, and one operations commander. Additional assignments for officers also include; Gang Intelligence, Criminal Investigations, Corrections Response Team, K9 handler, Diversion Program Officer, and Mental Health Officer. Corrections in Kane County is closely monitored by Sheriff Hain to ensure safety, control, and successful re-entry of citizens in to the community.

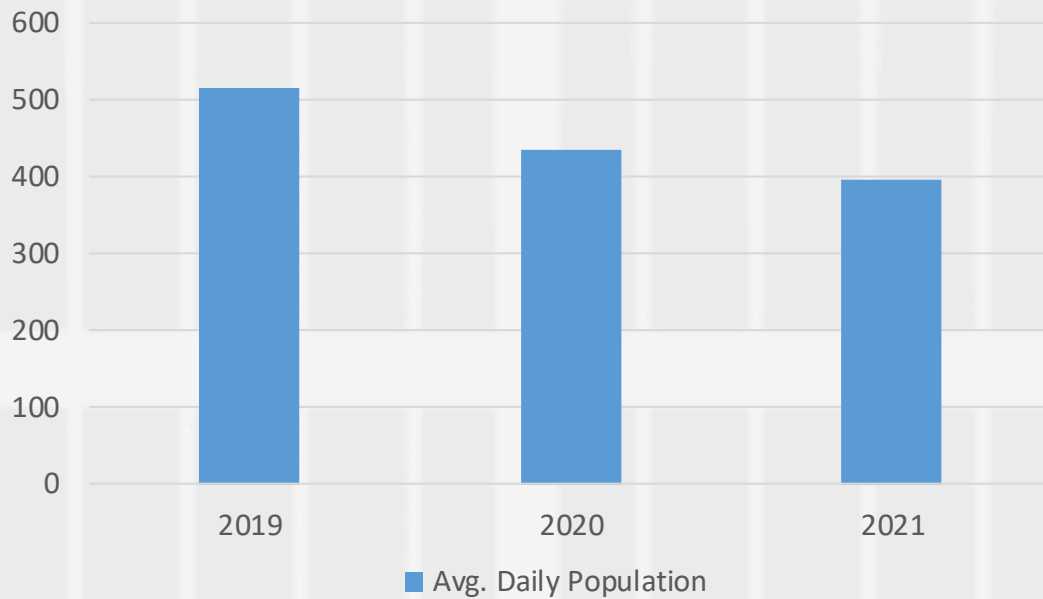

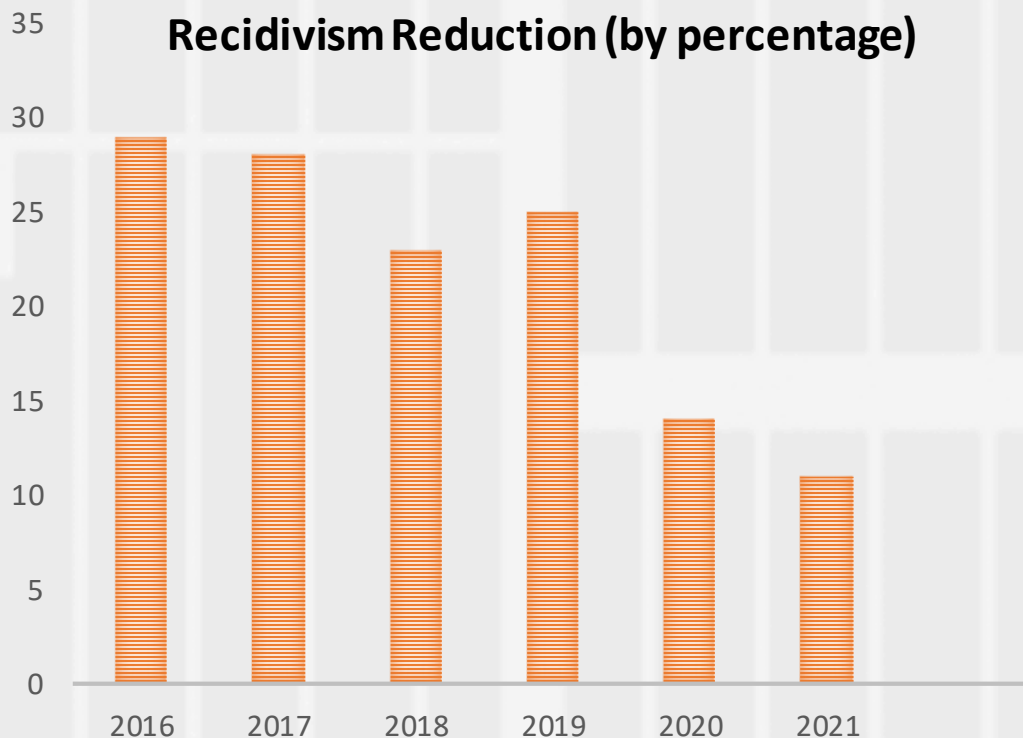

Adult Justice Center Census

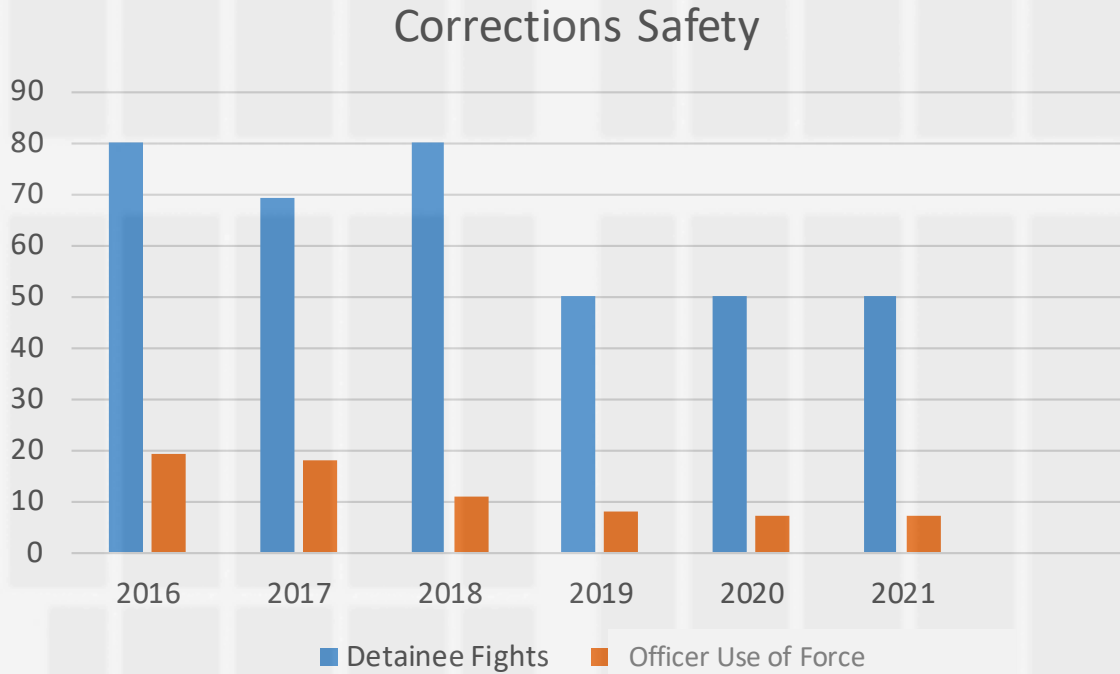


Recidivism Reduction (by percentage)



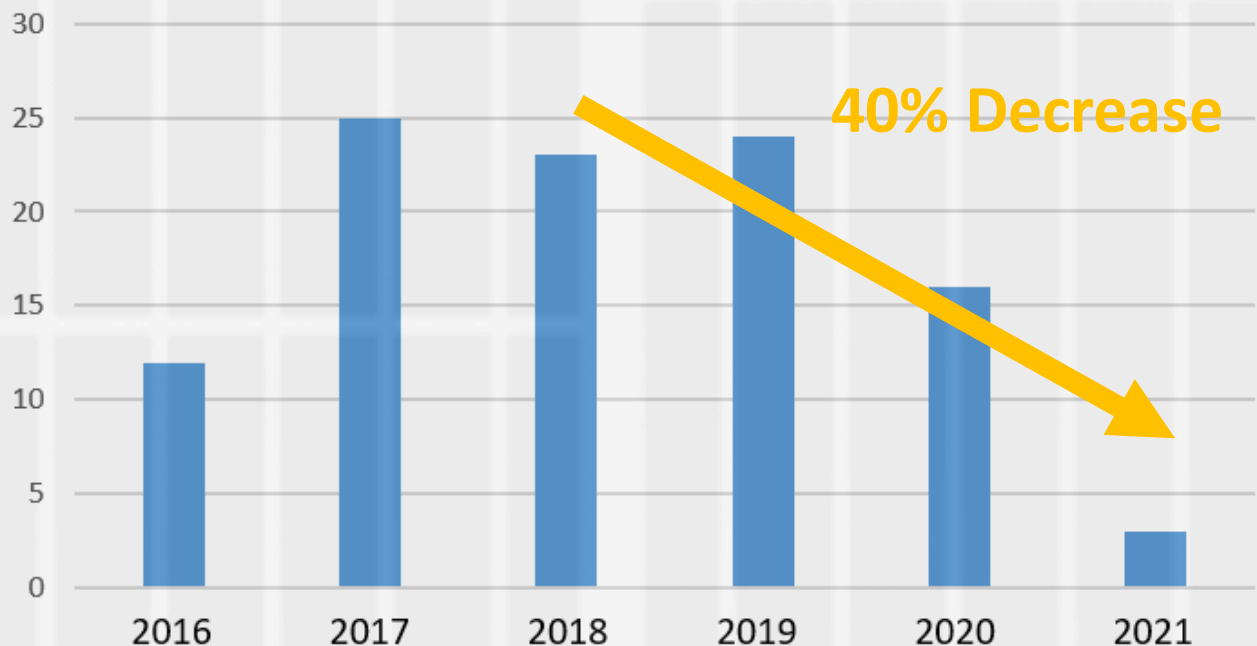
Through innovative diversion programs and the Sheriff's Office assuming control of electronic home monitoring for the county, the jail population has been reduced by 24% over the last three years. Recidivism has gone from a 6 year average of 49% down to 18% in 2021. This work is estimated to save Kane County tax payers **\$4,911,000** over the last three years.

Through our robust diversion programming we have maintained a 35% decrease in violence inside the Adult Justice Center over the last three years.

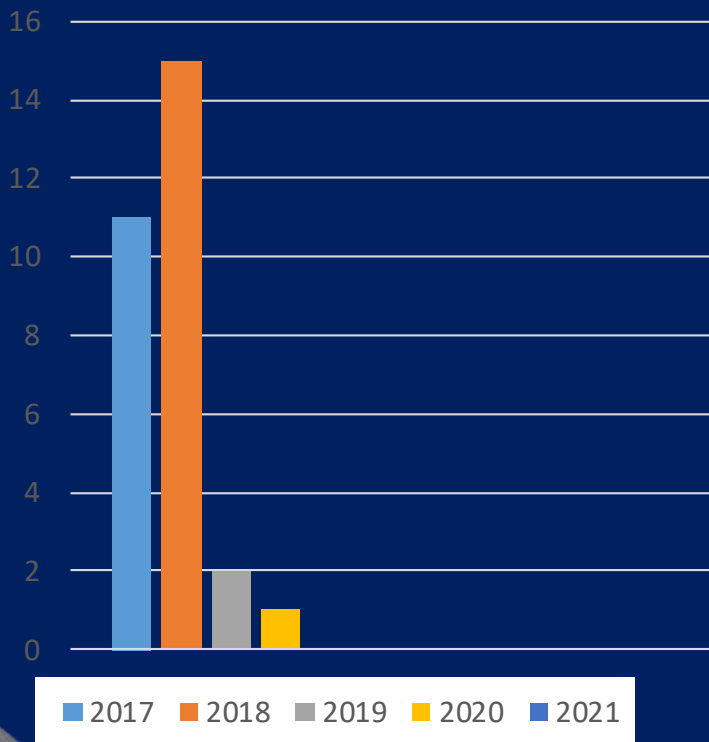

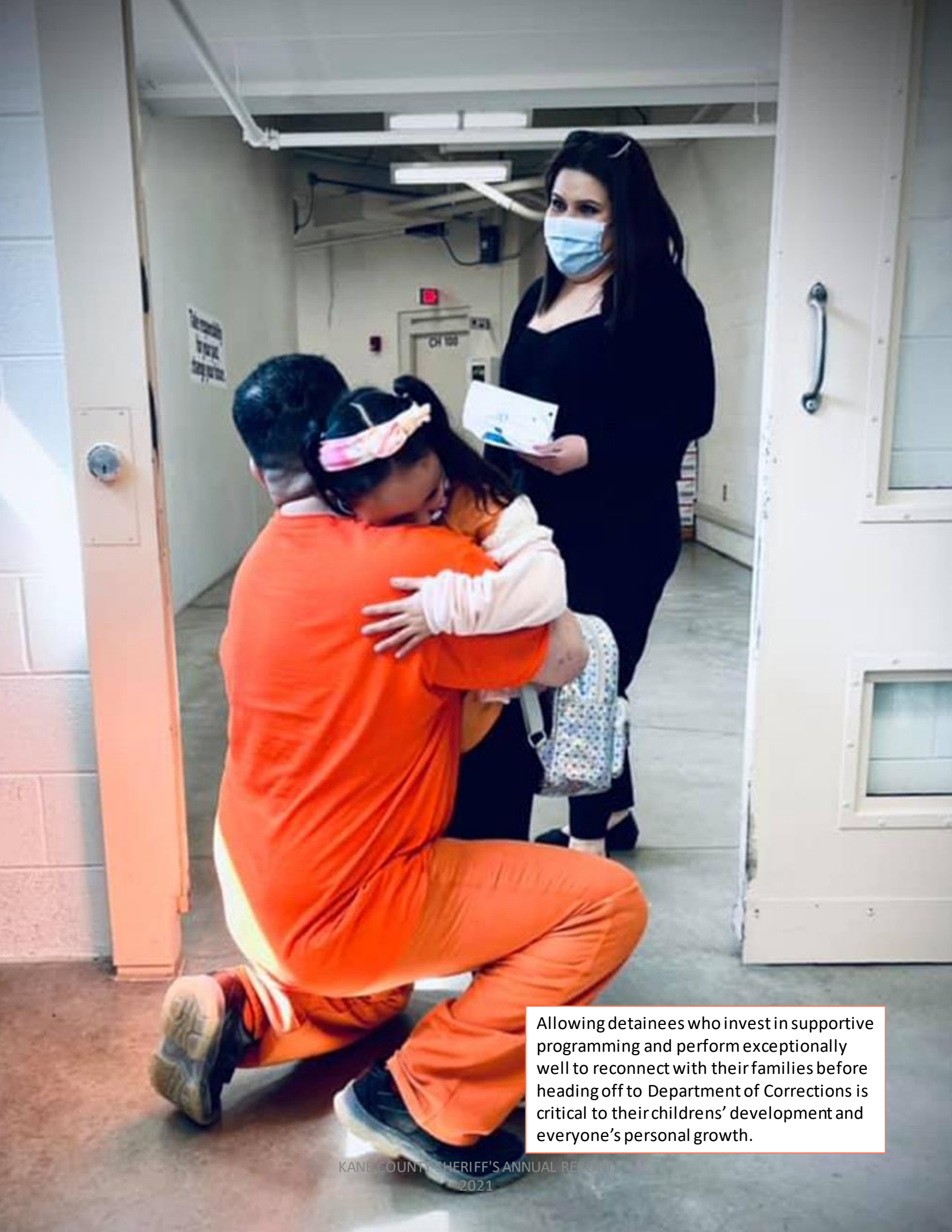
Returning Citizen OD Death

The Kane County Sheriff's Office offers a program called Lifetime Bonds, run by Dr. Keri Burchfield of NIU and Safe Humane in partnership with Aurora Animal Control, which allows detainees here at the Adult Justice Center to assist with preparing shelter dogs for adoption. Program participants learn how to care for, socialize, and train dogs using science-based, reward-based training techniques. They participate in positive, beneficial activities with dogs, such as dog agility and basic obedience. They, in turn, develop confidence and skills by working with the dogs. Participants are also taught about animal welfare and safety issues, such as pet overpopulation and animal abuse. All of the dogs featured are available for adoption.

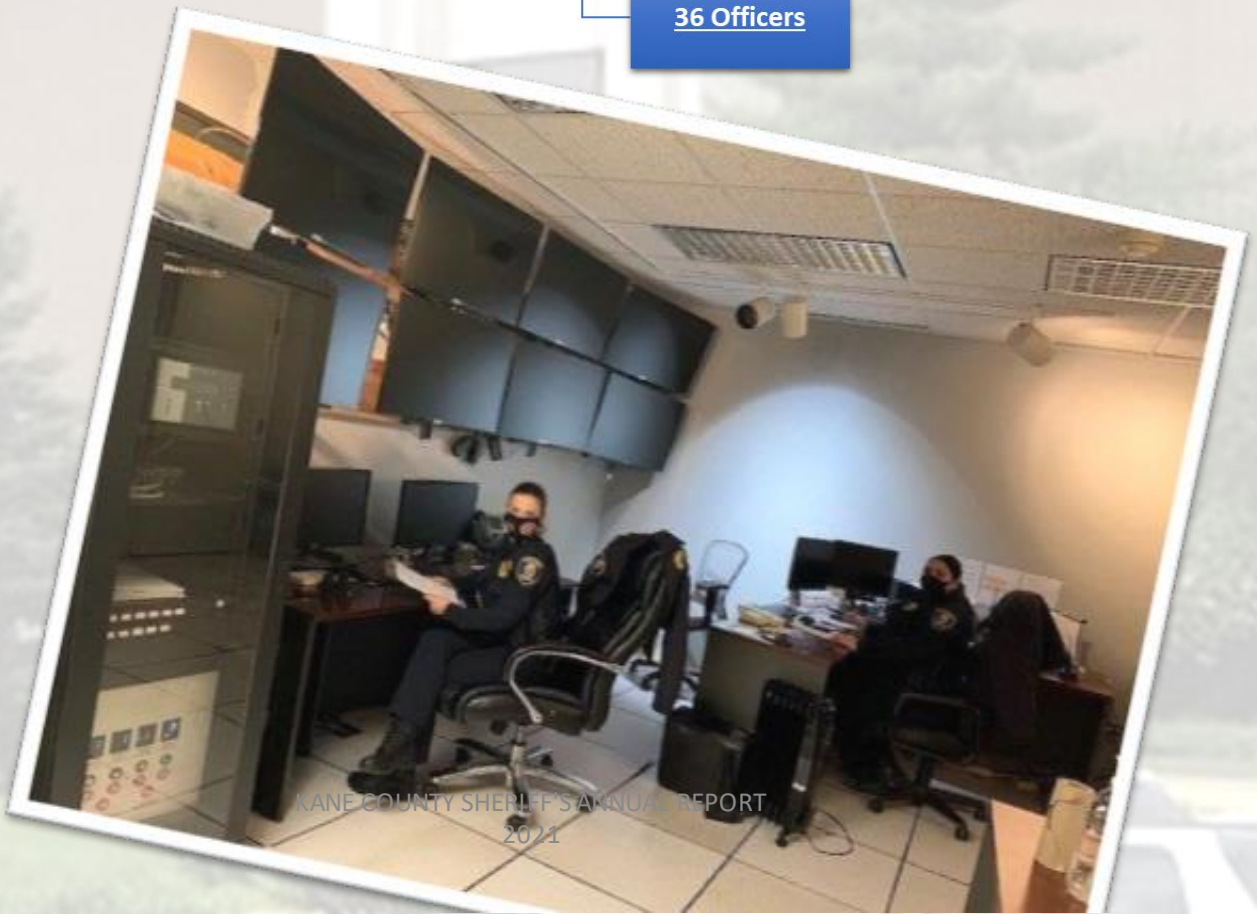

The Kane County Sheriff's Office Court Security Division, directed by Commander Lloyd Fletcher, is primarily charged with providing a safe and orderly environment to the Sixteenth Judicial Circuit System's judges and facilities in Kane County. The Sixteenth Judicial Circuit Courts are: Judicial Center in St. Charles, Juvenile Justice Center in St. Charles, Kane County branch of the St. Charles, Geneva Courthouse in Geneva, The Elgin branch court in Elgin, Carpentersville branch court in Carpentersville, and Aurora branch court in Aurora.

It is the responsibility of Court Security to provide a safe and secure environment for everyone who enters any one of the court facilities within the 16th Judicial Circuit. Every year there are approximately 700,000 people who go through the Screening process before they enter the facilities. Hundreds of prohibited items are detected and confiscated each year at the screening areas. Many of these items are not illegal but could be used as weapons to cause bodily harm.





Court Security is responsible for the handling of inmates in and out of the courtrooms and the courtroom holding areas.



Approximately 1,000 to 1,200 people are taken into Custody yearly at the court facilities for Batteries, Assaults, Thefts, Warrants, and Contempt of Court.

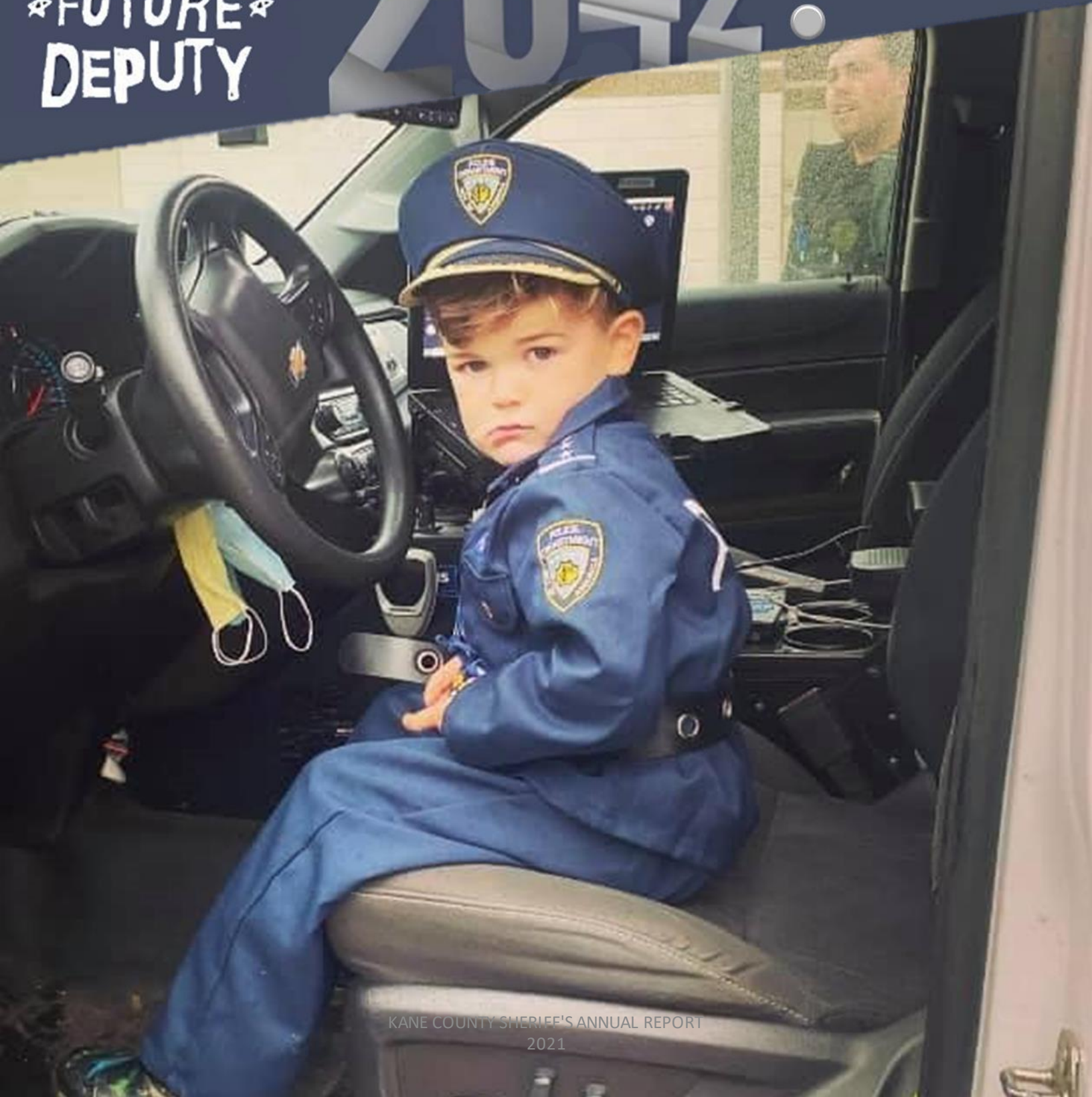
